

ROASTAR BIG PERK 2026 SWEEPSTAKES
OFFICIAL RULES

Eligibility: The Roastar Big Perk 2026 Sweepstakes is open only to participants 18 years of age or older who are legal residents of the fifty (50) United States or the District of Columbia.
