The trail can be accessed from the Sonoran Desert Drive entrance and is open daily from 5am to 11pm. The preserve offers


bathroom facilities and water fountains as well as plenty of parking.

## **Cranks &** Gears



#### True or False: 3 feet for passing is enough?

You may have thought that motorists are required to provide at least three feet when passing a bicyclist. That is how Statute ARS 28-735 (the law dealing with the distance needed when passing) is often discussed, but it is incomplete without looking at the entire law. The law requires more than just three feet. It requires that a motorist, "exercise due care by leaving a safe distance between the motor vehicle and the bicycle of not less than three feet". We think this is a critical distinction.

In some bicycle accident cases, motorists will argue they had given the necessary three feet at the time of the collision, but based upon the collision it seems evident that a safe distance was not left between the motorist and the bicyclists. No published cases have directly argued against this issue, but the language of the law is clear.
