LEGAL RUMBLES

HELMETS & PROTECTIVE GEAR

There are so many laws that it can be impossible to know every law that affects motorcycles and riders in any state, including Arizona. We thought it would be a good idea to highlight a few of the laws in Arizona that directly affect those who ride motorcycles. Some are boring, some controversial, but they all apply. So take a moment to read the statute we have chosen for this month. Far better to know the law than to find out after it is too late.

28-964. Motorcycles; all-terrain vehicles; motor driven cycles; equipment; exception; prohibition

A. An operator or passenger of a motorcycle, all-terrain vehicle or motor driven cycle who

is under eighteen years of age shall wear at all times a protective helmet on the operator's or passenger's head in an appropriate manner. The protective helmet shall be safely secured while the operator or passenger is operating or riding on the motorcycle, all-terrain vehicle or motor driven cycle. An operator of a motorcycle, all-terrain vehicle or motor driven cycle shall wear at all times protective glasses, goggles or a transparent face shield of a type approved by the director unless the motorcycle, all-terrain vehicle or motor driven cycle is equipped with a protective windshield. This subsection does not apply to electrically powered three wheeled vehicles or three wheeled vehicles on which the operator and passenger ride within an enclosed cab.

The Billet Bar, and more recently, The Dirty Dog.

When she started Tenderfenders™ she was on a mission to find a manufacturer with only one week left before the start of Bike Week 2009.

With a lot of support behind her, Monique sold 500 pieces in her first 45 days and it's been a good ride ever since.
