GLOVE SAFETY

If Jim Moore damages his hands...it will be more than just an inconvenience—as a builder of custom motorcycles a serious hand injury would mean loss of income. Most people think HELMET when it comes to safety gear. When Jim Moore was asked about safety gear, he said GLOVES.

Gloves not only help protect against pavement injuries but other hazards as well. Sun, wind, rain,

rocks & debris, and bugs can all be contributors to causing hand injuries. Gloves also protect against mere annoyance such a sweat hindering a solid hand grip.

There are a variety of motorcycle gloves and the proper choice will depend on what type of riding you'll be doing. Leather and textile gloves are best suited for street motorcyclists. If you're doing off-road motorcycling you'll want a glove specifically suited to a more rugged ride. Off-road gloves tend to be thinner in material and have more padding in areas that are likely to be subject to impact.

Once you've determined what type of riding gloves are best suited to you, look for a pair that fits comfortably, has good stitching for your protection, and are the proper length... And don't forget to protect your wrists as well your hands.


