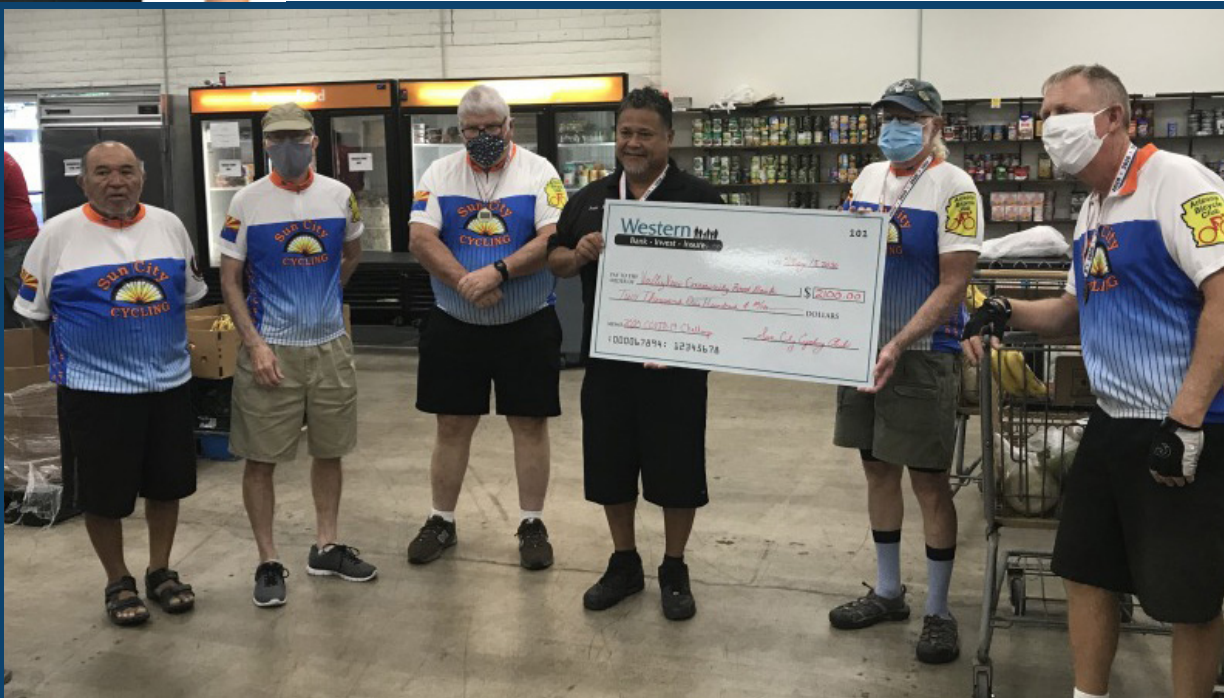

CYCLING THROUGH COVID-19

The Sun City Cycling Club, like any other group, was affected by the COVID-19 outbreak. Though cycling is outdoors and bicycle shops and outdoor activities are considered essential, group riding was suspended.

After the group made some adjustments, they were ready to ride, individually or in pairs. To keep the group together and to maintain fitness and mental well-being, the 2020 COVID-19 Challenge was created.

Forty-five members of the Club participated in the challenge. Each member committed to contributing \$1 for every mile they

rode in a 2-week period. A minimum \$25 donation to participate was requested, and some members opted to donate without riding.

The rides ranged from a Century (100 miles, 2 riders), Metric Century (62 miles, 12 riders), ½ Century (50 miles, 6 riders), ¼ Century (25 miles, 9 riders), or a mileage of their choice, (11 riders).

At the end of the challenge, the group rode 1,939 miles. Yes, they received a medal for the challenge completion, and donated over \$2,000 to the Valley View Food Bank and members of the Sun City Cycling Club.

The Sun City Cycling Club was established in 2016 and currently has 64 members. It is affiliated with PMBC (Phoenix Metro Bicycle Club), whose group rides are on Tuesdays and Thursdays.

Tuesday is dedicated to beginners or those who want to ride casually at 10 miles per hour. On Thursday, the more advanced team members head out and keep a pace of 15–16 miles an hour.
