A 10\% credit on your Swiss Re E\&O premium may be earned by attending a Swiss Re approved 3 hour risk management seminar prior to your policy anniversary (or within 30 days after your policy inception/renewal date). The number of agency staff required to attend is based on agency size. The credit is applicable for two consecutive policy terms.
