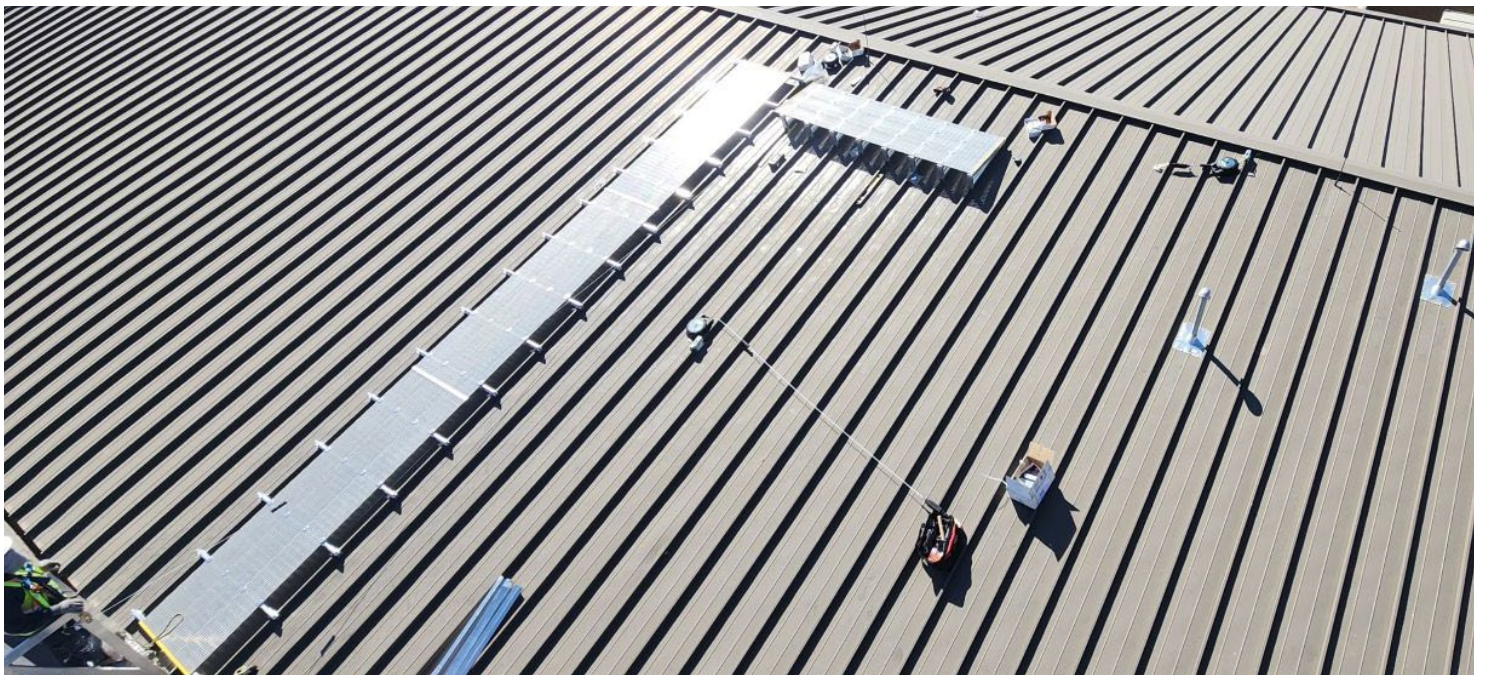

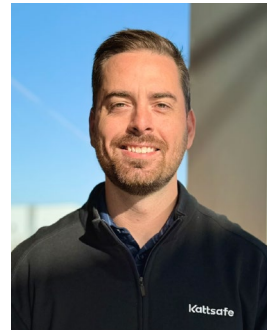

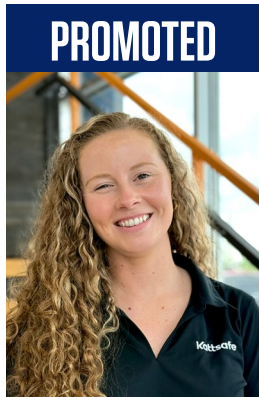

OSHA Releases Top 10 Safety Violations for 2025

At the 2025 NSC Safety Congress & Expo, OSHA announced its Top 10 Safety Violations, with Fall Protection leading for the 15th consecutive year, totaling 5,914 violations.

Top 10 Violations in 2025

1. Fall Protection – General Requirements (1926.501): 5,914 violations
2. Hazard Communication (1910.1200): 2,546
3. Ladders (1926.1053): 2,405
4. Lockout/Tag out (1910.147): 2,177
5. Respiratory Protection (1910.134): 1,953
6. Fall Protection – Training Requirements (1926.503): 1,907
7. Scaffolding (1926.451): 1,905
8. Powered Industrial Trucks (1910.178): 1,826
9. Personal Protective and Lifesaving Equipment – Eye and Face Protection (1926.102): 1,665
10. Machine Guarding (1910.212): 1,239

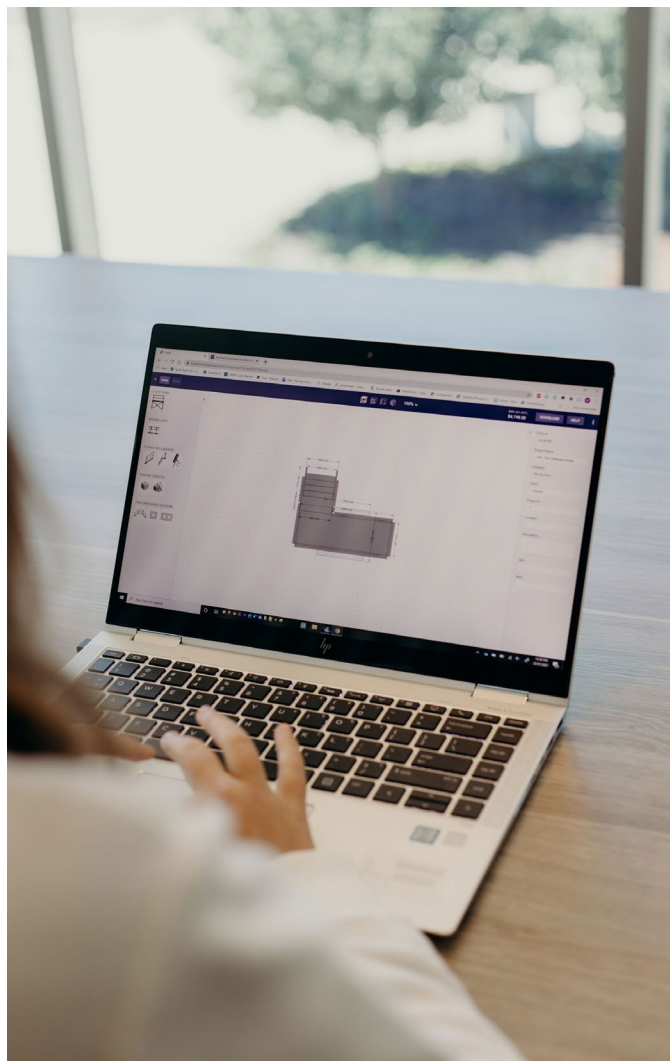
