Thank you for submitting a proposal in response to Wastewater Treatment Chemicals, Related Services, and Supplies Solicitation No. 24COR-017, issued by Little Rock Water Reclamation Authority ("LRWRA") in collaboration with CoreTrust Public Sector ("CoreTrust"). This document serves as notification that Thatcher Company, Inc. d/b/a Thatcher is the highest ranked vendor for the above referenced solicitation.

As provided in the solicitation, this *Notice of Intent to Award* is subject to execution of a written contract and, as a result, this Notice does not constitute the formation of a contract between Little Rock Water Reclamation Authority (LRWRA) and Thatcher. Thatcher **shall not** acquire any legal or equitable rights relative to the scope of work until a contract has been executed. Additionally, this *Notice of Intent to Award* is subject your successful completion of requirements contained in sections noted (below) of Request for Proposals (RFP) 24COR-017. Specifically, within 10 days of this notice, you are required to supply the following:

1. New Jersey Business Registration Certificate (Appendix A, Section D of the RFP)
2. Complete the Contractor Information tab provided on the final Section O [to become the resulting national cooperative price list] and provide Subcontractor Information, if applicable.

Award will be made by the LRWRA Procurement Department upon acceptance of the required documents by LRWRA. If you fail to provide the required documentation within the required time frame, you will be declared as non-responsive and LRWRA will be entitled to consider all your rights arising out to the LRWRA's acceptance of your bid as abandoned and as a forfeiture of your bid security. LRWRA **shall** have the right to cancel this *Notice of Intent to Award* at any time prior to the execution of a written contract.

Thatcher can commence sales under the resulting cooperative contract agreement only upon LRWRA and CoreTrust acceptance, LRWRA and CoreTrust approval, and posting of the awarded Contractor's contract and contact information on the CoreTrust website.

We will also confirm that all insurance requirements have been satisfied prior to the contract start date.

Please note that this procurement continues to be in a restricted period; therefore, communications concerning this procurement may only occur via a designated contact.
