Koepka thrilled to tee it up at home

PALM BEACH GARDENS, FL – Brooks Koepka has had his share of injuries during a career that will one day end up in the Hall of Fame. Some so severe they had him questioning if he'd ever reach the lofty standards he set while winning five major championships.

But the Palm Beach County, Florida, native never had to worry about being injured while playing hockey ... in his house ... with a 2 ½-year-old.

Until now.

Brooks and his wife, Jena, are proud parents who would do anything for their son, Crew. For Brooks, that means taking a stick to the face while preparing to play in his hometown PGA Tour tournament for the first time in three years.

“He watched a lot of hockey the last few days,” Brooks said about Crew, who also has graduated from plastic golf clubs to real irons. “Took a stick to the face the other day at the house, so that was interesting. It definitely hurts. I feel Jack Hughes and his pain a little bit, but didn't lose a tooth, thankfully.”

Hughes and his teammates have spent the last few days celebrating their victory that resulted in the USA's first Olympic men's hockey gold medal in 46 years. Koepka would like to do the same at the end of the weekend at the Cognizant Classic in the Palm Beaches, which will be played just minutes from his Jupiter home.

Koepka, 35, has not had that chance the last three years. He was ineligible to play in one of his favorite events after joining LIV Golf in 2022. But in January, Koepka and the PGA Tour reconciled, with Koepka agreeing to pay the price

for defecting, allowing a man who once was one of the tour's marquee names to return.

“It's nice to be able to be this close to home and to have everybody come out,” said Koepka, who was raised in Wellington and attended Cardinal Newman High School. “It's just enjoyable to see faces you haven't seen in a long time. Sometimes it's the only time I see people is when I'm here at this event. To win here would be pretty cool.”

Cognizant needs Koepka to win more than Koepka needs to win Cognizant Classic

As much as winning in his hometown would mean to Koepka, it would mean much more to the event that, as much as any on the PGA Tour, needs a boost.

And having hometown hero and fan favorite Brooks Koepka hoisting the trophy on the 18th green at PGA National on March 1 would give this tournament the

boost it desperately needs.

Koepka's history with the Cognizant goes back to when it was known at the Honda Classic and long before he even teed it up in the tournament.

Koepka returns to a tournament where he would carry the scoring sign for the professionals from the time he was about 10 through high school, not knowing one day he would be on the other end with some kid carrying a sign with his name.

“It was always a lot of fun getting up close to the guys, seeing everything,” he said. “And then being able to play in it, is special.”

After a decorated career at Florida State University, the 23-year-old rising star was given a sponsor exemption in 2014. Koepka had played six official PGA Tour events, including three majors, and made two cuts.

Part of a Honda field that included seven of the Top 10 players in the world, Koepka made the cut after shooting a 68 in the second round on a Champion Course that played much more difficult than it does now. He finished T33 with a 2-under 278.

The next year, Koepka got the star treatment playing the first two rounds with world No. 1 Rory McIlroy and No. 16 Dustin Johnson. But by then his star was rising and he was No. 19.

Once was best player on planet

So much has changed since then, including the kid who once carried a sign for Jeff Maggert, Scott Gutschewski and Stephen Ames rising to No. 1 in the world and becoming the best player on the planet for about a two-year period, picking off majors at an impressive rate.

Now, with three PGA Championships and two U.S. Opens among his nine PGA

Tour titles, Koepka's career definitely enters another phase.

One with LIV Golf in the rearview mirror. And with new priorities.

Following his round each day, he either will be greeted by Crew or rush home to see him. Crew will be in school the first two rounds and is expected to join his mom at course on the weekend. That is if dad makes the cut, of course.

“It's super enjoyable,” Koepka said about balancing being a dad and professional golfer. And that job became a lot easier when he stepped away from the final year of a LIV contract that reportedly paid him \$125 million.

“I rushed home (Feb. 24). I got out of here by probably 6:40 maybe and was just trying to rush home to catch him right before he went to bed.”

Now the question is will Koepka being more relaxed and more at peace with his life recapture his form on the golf course? Since winning the 2023 PGA Championship, which came 11 months after joining LIV, Koepka's game has suffered. He is coming off his worst majors season.

Koepka admitted to being nervous at his PGA Tour return at the Farmers Insurance Open. But that is in the past. And in the past, too, he hopes, are the putting woes that plagued him in his first two tour events. He finished tied for 56th at Farmers and a week later missed the cut at the Phoenix Open.

The struggles forced him to switch putters. He feels confident the Champion Course's firm greens will not pose a problem.

“Having two weeks of being able to get work done and make some adjustments, it should be a lot better,” Koepka said.

Something he's now able to say about his new life back on the PGA Tour.

LSU's Johnson uses 'Choose Better' as fuel

LSU Tigers guard Flau'jae Johnson has a two-word motto ahead of an NCAA Tournament run with LSU.

“Choose better,” Johnson told USA TODAY while promoting a partnership with sports drink brand Bodyarmor. “That's literally who I am in every facet of my life.”

Fittingly, the sports drink brand has a March Madness campaign, focused on hydration and recovery, with the same name. However, for Johnson, it's more than a campaign. It's how she operates.

“Choose better in every facet of my life: my mental, my preparation, my body. What I put into my body is very important to me. It's just choosing better in everything that I do, especially as an athlete,” Johnson said. “I feel like taking care of your body is the No. 1 thing you have to do. For me, it's in every facet of life. When I'm into something or when I'm doing anything – and that's my athletics (and) my music – I'm trying to choose better. I'm trying to be the best version of myself.”

Johnson, in her senior season with LSU, says she's focused on staying grounded ahead of her fourth NCAA Tournament appearance. The Savannah, Georgia, native told USA TODAY she's made a conscientious effort to make recovery the center of how she stays calm through the season. Johnson says if she doesn't recover her mind, her body inevitably “won't go as hard” as she needs.

She's been particularly cognizant of

that as LSU makes a push for another title, its first since the 2022-23 season. Johnson, who was on that national championship roster, understands what it takes to win at the highest level. Those lessons have come in handy when this year's roster struggled around the halfway point of the season.

LSU opened SEC play with back-to-back losses to Kentucky and Vanderbilt, something the LSU guard had never experienced. What's more, against the Commodores, Johnson was held scoreless for the second time in her career. The losses were seemingly a wake-up call for LSU. The Tigers guard says the team had to come together, look in the

mirror and start asking questions.

“Who do you wanna be? What kind of team do you wanna be? What kind of player do you want to be?” Johnson said. “As we just decided that and we came to a consensus, I think we just learned who we wanted to be and our identity ... that being a team and seeing each other win and making that extra pass and rebounding the ball, that's who we are. We just gotta understand that and get back to that.”

Following the losses to Kentucky and Vanderbilt, LSU won 10 of its next 12 matchups, including seven in a row. The streak boasted ranked wins over Texas, Oklahoma, Alabama and Ole Miss.

LSU's 78-70 win over the Rebels was especially gritty as the Tigers were down by as much as 13 before roaring back in the fourth quarter. LSU held Ole Miss to seven points in the fourth.

That sort of tenacity and focus is what LSU needs as it finishes the season. The Tigers will see many of the teams they just beat in the SEC Tournament, which begins March 4.

Johnson says what gets lost in the grind of March Madness is teams are playing games just about every day and traveling “across the world,” depending on the region. She also says all the good vibes LSU has built up now won't really matter.

“You gotta flush it. If you have a 30-point game and you have a game-winner, it don't matter the next game. If your head's not on a swivel, you're out,” Johnson said. “That's definitely the most important part of the NCAA Tournament. That's why you have to be (level). Can't get too high. Can't get too low – until you get that ring.”

LSU has regular-season games remaining, against Tennessee on Feb. 26 and Mississippi State on March 1. The Tigers need to dial in for a deep March Madness run now.

Johnson told USA TODAY that to get back to the Final Four and walk away with a title LSU will need to do two things.

“Defense and rebounding. That's all we gotta do,” she said, smiling. “We play defense, and we rebound, the offense will take care of itself. We'll get what we want, but if we defend and rebound, we'll be in a good space. I'll tell you that.”

Stewart’s championship haul prior to March 4:

- Two high school state titles.
- Four NCAA championships at UConn.
- Three WNBA titles with the Seattle Storm and New York Liberty.
- Three Olympic gold medals with Team USA.

Now, she is also an Unrivaled cham-

pion after helping the Mist BC defeat the Phantom BC, 80-74, on March 4 at Sephora Arena in Miami.

It was the second season of the league Stewart helped co-found with former UConn teammate Napheesa Collier.

“I pride myself on being a winner and continuing to kind of uplift and build a space for all players,” Stewart said, “and that’s what I’m really excited about.”

The end of the title game was somewhat anticlimactic. Stewart was first charged with an offensive foul, but when the call was overturned, she shot free throws to seal the Mist victory. She finished with an Unrivaled career-high 32 points. She grabbed four rebounds,

had two steals and two blocks. Arike Ogunbowale added 19 points off the bench and Allisha Gray 12 points for the Mist.

The six Mist players earn \$100,000, up from the \$50,000 every Rose player earned for last season’s title.

Kelsey Plum scored 40 on 14-for-21 shooting for the Phantom, who entered the tournament as the No. 1 seed. Kiki Iriafen added 13 and Tiffany Hayes 12.

The Mist led by six points going to the fourth quarter, which in Unrivaled rules is untimed. The league adds 11 points to the score of whichever team is leading at the end of the third quarter and that is the target score. In this case, first team to 79 points won.

McDuffie first blockbuster trade of 2026 NFL free agency

The Los Angeles Rams are jumping the gun on improving their roster by pulling off a blockbuster trade days before free agency.

The NFC runners-up are acquiring cornerback Trent McDuffie from the Kansas City Chiefs, USA TODAY Sports’ Tyler Dragon has confirmed. Kansas City will receive the Rams’ No. 29 overall pick in the 2026 draft, as well as two third-day picks and a 2027 draft pick. The trade will be finalized when the new league year begins on March 11.

ESPN’s Adam Schefter was the first to report the transaction on March 4.

McDuffie, 25, is entering his fifth

NFL season and the final year of his rookie contract. Since the Chiefs drafted him in the first round in 2022, he’s earned one first-team All-Pro nod in 2023 and a second-team All-Pro honor in 2024.

In 2025, the University of Washington product recorded 63 tackles, seven pass defenses and an interception. A knee injury near the end of the year landed McDuffie on season-ending injured reserve after Week 14.

The Rams ranked 19th in the NFL with 216.7 average passing yards allowed per game in 2025. With safety Kamren Curl and cornerback Cobie Durant set to hit free agency next week, the Rams get a head start on improving their secondary by trading for McDuffie.

Cowboys restructure three contracts to slide under cap

The Dallas Cowboys managed to limbo underneath the NFL’s 2026 salary cap with one week to spare.

Dallas restructured the contracts of three key players – quarterback Dak Prescott, wide receiver CeeDee Lamb and offensive lineman Tyler Smith – to free up roughly \$66 million, according to ESPN, making the Cowboys cap-compliant.

ESPN reported that the Cowboys were roughly \$55 million over the cap prior to restructuring the three contracts. OverTheCap lists Dallas’ current available cap space at \$8.5 million as of the afternoon on March 4, still one week out from the start of the 2026-27 league year and NFL free agency on March 11.

According to ESPN, all three players’ contracts were restructured by turning a significant portion of their base salaries into signing bonuses for cap purposes. Prescott’s 2026 base salary is now \$1.8 million, down from \$40 million. Lamb and Smith’s base salaries “drop to the \$1.7 million range,” per ESPN’s Todd Archer.

Prescott’s cap hit in 2026 drops to \$43.7 million as a result of the restructure, according to OverTheCap. Lamb’s drops to \$20 million and Smith’s to \$11.2 million. However, all three players’ cap hits inflate significantly in 2027: Prescott’s 2027 cap hit is nearly \$76 million, Lamb’s is \$46.2M and Smith’s is \$19.5M.

Cowboys owner and general manager Jerry Jones said at the NFL combine that Dallas will also work to restructure at least three more contracts

– those of defensive tackles Kenny Clark, Osa Odighizuwa and Quinnen Williams – to create extra salary cap room.

“I would bet that we will spend more money in free agency than we have,” Jones said at the scouting combine. “I want you to know that the only way to push more is for me to go borrow some of my future, OK? Expect me to go borrow some of my future.”

George Pickens, on whom the Cowboys placed their franchise tag this offseason, currently counts \$27.3 million against the team’s 2026 cap. That number could also deflate with a long-term extension.

The Cowboys now rank 18th in the NFL in salary cap space.

Mammoth acquire Flames’ MacKenzie Weegar

March 4 was a day for NHL defensemen to change teams ahead of the league’s trade deadline at 3 p.m. ET March 6.

Tyler Myers got the ball rolling by accepting a trade from the Vancouver Canucks to the Dallas Stars. The 6-foot-8 Houston native will be playing in his home state on the same team as 6-foot-7 defenseman Liam Bischel.

Nick Blankenburg also moved from the Nashville Predators to the Colorado Avalanche for a 2027 fifth-round pick.

But the biggest move of the day was the Utah Mammoth acquiring defenseman MacKenzie Weegar from the Calgary Flames.

“Acquiring MacKenzie solidifies our back end as we continue to push towards the playoffs, and he will be a great addition to our team on and off the ice,” Mammoth general manager Bill Armstrong said.

MacKenzie Weegar trade details

The Mammoth acquired defenseman MacKenzie Weegar from the Flames for defenseman Olli Määttä, forward

Jonathan Castagna and three 2026 second-round picks (Utah’s own and others previously acquired from the Ottawa Senators and New York Rangers).

Mammoth trade grade: A-

Armstrong has been aggressively re-making the defense since the team moved to Utah in 2024. He added Mikhail Sergachev, John Marino and Ian Cole that first season and Stanley Cup winner Nate Schmidt last summer. Weegar gives the Mammoth a solid top four as they try to hold onto their wild-card position. And the Mammoth

landed him without trading Tij Iginla, who would seem a natural to be part of a trade to Calgary, where his father, Jarome, had starred.

Flames trade grade: B-

Considering that Weegar is signed through 2031, it’s surprising that the Flames didn’t pry away a first-round pick. But three second-rounders are good in what’s expected to be a deep draft. Olli Määttä is a pending unrestricted free agent, and Castagna, a third-round pick, is averaging a point a game in his third season at Cornell.

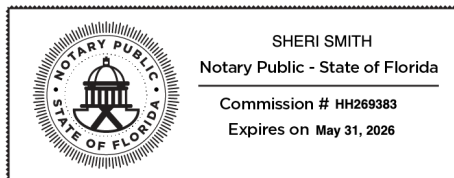
