Chambliss’ lawyers seek injunction

Ole Miss football and quarterback Trinidad Chambliss are still aiming for another year of eligibility, despite the NCAA denying their claim Jan. 9.

Chambliss’ lawyers plan to file suit against the NCAA in Mississippi state court for a preliminary injunction, per multiple reports. Chambliss’ attorney, Tom Mars, released a statement Jan. 11, noting Chambliss’ team anticipates filing the suit before the end of the week.

“We expect the lawsuit to be far more detailed and documented than other eligibility lawsuits that have been filed in the past year,” Mars said in a statement. “Therefore, considerable work needs to be done before we’ll be prepared to seek an injunction that would allow Trinidad to play next season.”

Chambliss, a first-year Division I starter after transferring from Division II Ferris State, was hoping to receive a retroactive redshirt for the 2022 season, in which he didn’t appear in a game due to medical issues. He also redshirted in 2021, meaning he only appeared in games for three seasons from 2023 to 2025.

Ole Miss athletic director Keith

Carter said on social media the school would appeal the NCAA’s decision after Chambliss was denied the extra season.

The breakout star of the College Football Playoff, Chambliss passed for 362 yards and two touchdowns in Ole Miss’ upset win over Georgia in the Sugar Bowl. He threw for 277 yards and a touchdown in the Rebels’ narrow 31-27 defeat to Miami at the Fiesta Bowl.

Chambliss finished the 2025-26 season with 3,937 passing yards and 22 touchdowns to three interceptions, along with 527 rushing yards and eight scores. He was eighth in the Heisman Trophy voting. Ole Miss has since added former Auburn 5-star quarterback Deuce Knight, who has four seasons of eligibility left, via the transfer portal.

Why was waiver denied by NCAA?

The NCAA issued a lengthy statement Jan. 9 regarding Chambliss and Ole Miss’ waiver request and why it was denied.

“In November, Ole Miss filed a waiver request for football student-athlete Trinidad Chambliss, seeking to extend his five-year Division I eligibility clock, citing an incapacitating illness or injury,” the NCAA wrote.

“Approval requires schools to submit medical documentation provided by a treating physician at the time of a student’s incapacitating injury or illness, which was not provided. The documents provided by Ole Miss and the student’s prior school include a physician’s note from a December 2022 visit, which stated the student-athlete was “doing very well” since he was seen in August 2022.

“Additionally, the student-athlete’s prior school indicated it had no

documentation on medical treatment, injury reports or medical conditions involving the student-athlete during that time frame and cited “developmental needs and our team’s competitive circumstances” as its reason the student-athlete did not play in the 2022-23 season. The waiver request was denied.

“This decision aligns with consistent application of NCAA rules. So far this academic year, the NCAA has received 784 clock extension requests (438 in football). Of those, 25 cases cited an incapacitating injury (nine in football). The NCAA approved 15 of those (six in football), and all 15 provided medical documentation from the time of the injury. Conversely, all 10 that were denied (three in football) did not provide the required medical documentation.

“To receive a clock extension, a student-athlete must have been denied two seasons of competition for reasons beyond the student’s or school’s control, and a “redshirt” year can be used only once. One of the rules being cited publicly (Bylaw 12.6.4.2.2) is not the correct rule for the type of waiver requested by the school. Ole Miss applied for the waiver in November, and the NCAA first provided a verbal denial Dec. 8.”

QB Raiola commits to Oregon after 2 seasons as Nebraska’s starter

Former 5-star Nebraska quarterback Dylan Raiola committed to Oregon on Monday Jan. 12, he announced on Instagram.

A two-year starter for the Cornhuskers, Raiola was one of the top available quarterbacks in the transfer portal. He chooses Oregon, which could potentially need a starter for next season with Dante Moore potentially leaving for the NFL.

Raiola passed for 2,000 yards with 18 touchdowns to six interceptions in nine games in 2025 before suffering a season-ending broken fibula injury against Southern Cal on Nov. 1.

He was the No. 14 prospect and No. 5 quarterback of the transfer portal class, according to 247Sports.

It’s unclear if Raiola’s commitment means Moore is heading to the NFL. The projected first-round pick has only been a full-time starter for one season of college and said after Oregon’s Peach Bowl loss to Indiana that he’s still undecided on his future.

Raiola’s uncle, Donovan Raiola, was fired by Nebraska coach Matt Rhule on

Dec. 6 after five seasons as offensive line coach.

Raiola’s younger brother, 3-star quarterback Dayton Raiola, de-committed from Nebraska on Nov. 19.

Raiola ultimately chose Nebraska out of high school despite committing to multiple other schools. He was once pledged to both Ohio State and Georgia before flipping to the Cornhuskers late in his recruitment.

The Buford, Georgia, native passed for 2,819 yards with 13 touchdowns to 11 interceptions as a true freshman, completing 67.1% of his passes. Raiola boasts a 69.1% completion rate through two seasons as a starter.

The son of former 14-year NFL veteran offensive lineman Dominic Raiola was the No. 21-ranked recruit and No. 3 quarterback of the 2024 high school recruiting class, according to 247Sports’ Composite.

Raiola has started since his true freshman season at Nebraska. In that time, he has thrown for 4,819 yards on 456-of-660 passing (69.1%), with 31 touchdowns and 17 interceptions.

- 2024: 275 of 410 passing (67.1%), 2,819 yards, 13 touchdowns, 11 interceptions.
- 2025: 181 of 250 passing (72.4%), 2,000 yards, 18 touchdowns, six interceptions.

Leavitt commits to LSU out of transfer portal after visit

Lane Kiffin finally has his quarterback.

Kiffin and the LSU football program landed a transfer portal commitment from Arizona State’s Sam Leavitt on Monday Jan. 12, according to multiple reports. Leavitt is the No. 1-ranked player in the transfer portal, according to 247Sports.

It took the Tigers until the final days of the transfer portal window, which lasts from Jan. 2 to Jan. 16, to find their starting quarterback for next season. Leavitt is LSU’s second quarterback commitment of Jan. 12, joining Elon’s Landen Clark.

Leavitt was heavily sought after by numerous programs, including Miami, Tennessee and Kentucky, each of which he visited. He’s an important addition for LSU, with former starters Garrett Nussmeier out of eligibility and Michael Van Buren transferring to South Florida, along with the addition of a new coaching staff.

Leavitt passed for 1,628 yards with 10 touchdowns to three interceptions in seven games this season, also rushing for 306 yards with five scores. The preseason Big 12 Player of the Year suffered a season-ending injury against Houston on Oct. 25.

Leavitt led the Sun Devils to a Big 12 championship and College Football Playoff bid in 2024 after passing for 2,885 yards with 24 touchdowns to six

interceptions as a redshirt freshman after transferring from Michigan State. He has two seasons of eligibility remaining.

Kiffin first hosted Cincinnati’s Brendan Sorsby in the first few days of the transfer portal window, before Sorsby chose Texas Tech. Kiffin was also unable to coax former Mississippi starter Trinidad Chambliss to join him and former Ole Miss offensive coordinator Charlie Weis Jr. at LSU.

Washington quarterback Demond Williams Jr. was also rumored to LSU after briefly entering the transfer portal but opted to stay with the Huskies.

Kiffin alluded to traveling to Knoxville, Tennessee, to see Leavitt after Leavitt’s visit to Tennessee on social media.

Leavitt posted 303 total yards with two touchdowns in Arizona State’s 30-22 upset win over Texas Tech on Sept. 21, which was the Red Raiders’ only regular-season loss before falling to Oregon in the CFP.

Leavitt is set to lead a new-look LSU roster that has added 25 transfer portal recruits already ahead of Kiffin’s first season with the program.

Leavitt’s yearly stats:

- 2023 (Michigan State): 15 of 23 passing for 139 yards, two touchdowns, two interceptions.
- 2024 (Arizona State): 216 of 350 passing for 2,885 yards, 24 touchdowns, six interceptions.
- 2025 (Arizona State): 145 of 239 passing for 1,628 yards, 10 touchdowns, three interceptions.

Draft-declared Simpson gets offers from schools

Alabama football quarterback Ty Simpson has declared for the 2026 NFL draft. But his declaration has not stopped teams from sending offers to Simpson’s camp for him to return for one last college football season.

According to a person close to Simpson, Miami sent the Alabama quarterback an offer to be the highest-paid player in college football at \$6.5 million. The Hurricanes’ official offer started at

\$4 million and quickly ballooned to \$5 million within minutes before reaching the current offer. Tennessee and Ole Miss, according to the source, offered Simpson \$4 million.

In 2025, Simpson’s base salary at Alabama was \$400,000, according to a person close to Simpson. It doubled to \$800,000 with incentives.

As of Sunday Jan. 11, Simpson is not in the NCAA transfer portal. He also has

not yet signed his NFL paperwork but is preparing to travel to Mobile for the Senior Bowl.

According to the source, Simpson and his family have had “restless hours” talking through offers received. But the expectation is for Simpson to remain in the NFL draft as one of the top three quarterbacks on the board along with Indiana’s Fernando Mendoza and Oregon’s Dante Moore.

In the 2025 draft, the New York Giants signed former Ole Miss quarterback Jaxson Dart to a four-year, \$17

million contract with a \$9 million signing bonus, all of which was guaranteed, per ESPN. Dart was drafted 25th overall.

Simpson is also pulled to having his legacy being tied to Alabama and the Crimson Tide being his alma mater in the NFL. In 2025, Simpson led the SEC with 305 completions and 473 pass attempts. He had 3,567 passing yards, 30 total touchdowns and five interceptions.

Austin Mack and Keelon Russell are expected to battle for Alabama’s starting quarterback job in 2026.

Texans need to ‘stop beating themselves’

FOXBOROUGH, MA – Houston, we have a quarterback problem.

Following the Texans’ 28-16 loss in the AFC divisional round playoffs – the third straight season that has ended at this stage for DeMeco Ryans’ team – to the New England Patriots on Jan. 18, quarterback C.J. Stroud said he felt like he let his team down.

Four interceptions – all in the first half – justified his feelings. But it wasn’t just about his pair of sloppy performances from both postseason games, which included a win over the Pittsburgh Steelers six days prior in the wild-card round. Since an electrifying rookie season, Stroud has regressed over the past two seasons and been a crutch for a team that consistently boasts elite defenses, especially the 2025 version.

“I just feel like I let people down, and I’m not happy with that,” Stroud said. “It hurts, and I’m not naïve to it. I didn’t play my best this year, but I’m going to respond. I’m going to keep my chest up, my chin up high, and I’m going to just keep battling forward.”

Progress has largely evaded Stroud. Just ask Troy Aikman, who was calling the game for ESPN. “(Stroud) has been chasing his rookie success for the last two years,” Aikman said in the final minutes of the game. “He’s not been the same player. We’ve not seen the development from him. There’s a reason for that, and it has to be addressed.”

Stroud became the first player in NFL history to throw five interceptions and fumble the ball five times in a single postseason. He accomplished that unfortunate history in less than six quarters of action.

“C.J. is our guy,” Ryans said. “I believed that he could come back out in the second half and flip it. I believed that he could play better, and he did that in the second half.”

Houston moved the ball better in the final 30 minutes, but it didn’t result in TDs. Stroud was 20-for-47 with 212 passing yards and sacked three times.

Ryans tried to shield his quarterback from criticism by assigning himself the most blame. “We have a really special group, a tight-knit group, and when things don’t go your way, you have bad

performances, it’s not a time to point fingers or say it’s on one person,” he said.

How close this team became over a 10-game winning streak, after a 0-3 start that had everybody counting the 2025 Texans out, is “what kills you when you lose,” linebacker Azeez Al-Shaair said.

“That’s what makes it such a blessing when you can reflect on how far you’ve come,” he said. “From where this team started to where this team ended up?”

When last season ended at the hands of the Kansas City Chiefs in the divisional round, Al-Shaair felt his “terrible” game was the reason for the loss. He remembers sitting in the Arrowhead Stadium visitors locker room and not being able to face his teammates. His instruction to Stroud was to not forget the feeling – let it fuel the next season.

“I know exactly what it feels like to feel like you let the team down,” Al-Shaair said. “You just truly believe that you’re going to find a way to win this ball game.”

Stroud appreciated the conscientious effort of his teammates to comfort him during a distressing time.

“I’m really appreciative of this team and them doing that because they didn’t have to,” Stroud said. “But yeah, it was not easy. It’s something that I’m going to learn from. I’m just grateful my teammates were picking me up.”

Stroud was without Nico Collins, who suffered a concussion during the Pittsburgh game. Tight end Dalton

Schultz departed in the first quarter with a calf injury. That left him targeting third-year wideout Xavier Hutchinson 13 times. Rookie Jayden Higgins had 10 targets.

Hutchinson referred to Stroud as one of the best quarterbacks in the league. “I believe that. It wasn’t the best game for a lot of us. That’s just how the ball goes, sometimes,” Hutchinson said.

For the team to take that next step and start competing for Super Bowls, Hutchinson said they needed to “stop beating themselves.”

“It doesn’t feel great. It’s just plain and simple,” he said. “You can’t beat yourselves in the playoffs, and that’s exactly what we did today. A lot of times, we got in our own way.”

For that, the conductor – the quarterback – deserves requisite ridicule, given the stage and the stakes. That applies to all quarterbacks who turn the ball over multiple times in a game of this magnitude, Josh Allen of the Buffalo Bills included.

There were plenty of drop-backs against Mike Vrabel’s defense in which Stroud had nowhere to throw and nobody to throw to. The conditions were not conducive to the clean delivery of the football, although the dry setting of the Jan. 12 game didn’t prevent him from putting the ball on the ground five times (he recovered three of his fumbles). But the pick-six he surrendered Sunday, when K’Lavon Chaisson chased Stroud down on a partially broken play, could have been avoided by throwing the ball

away or taking a sack. “It’s something I can learn from, and it just sucks that it has to be in this game, in this environment, on this stage,” Stroud said.

For the divisional-round delusion – the team is 0-3 with the Ryans-Stroud coach-QB pairing but has at least advanced to the round in their first three seasons together – to cease in Houston, Stroud has to clean up the inconsistencies. He has a case of botching the easy plays but converting the difficult ones. Peyton Manning recently said that doing the boring thing, for a quarterback, is an acquired skill. Stroud did that with ease as he rolled to 2023 Offensive Rookie of the Year, and he was eighth in MVP voting. The two following seasons have seen less production, more turnovers, the changing of offensive coordinator from Bobby Slowik to Nick Caley and more frustration.

In one breath, Stroud can put the ball in a place only Higgins can catch it on a key third down. And in the next, he’s throwing with zero direction to the sideline and being intercepted by Carlton Davis with 1:37 left in the first quarter.

Sometimes it is his fault, sometimes it’s not.

“I believe C.J. has done a lot of great things throughout this entire year,” Ryans said. “I know C.J. I know what it means to him. If anybody, you think about how anybody is feeling at this moment, you think about C.J. I think about the man, first and foremost. It’s not about the player.”

Stroud credited the McNair family and Texans ownership for bringing in general manager Nick Caserio and Ryans to stabilize the organization. He sees a bright future in Houston. Will Anderson Jr., the stud defensive end who had three sacks and forced two of Patriots quarterback Drake Maye’s four fumbles, told reporters he and Stroud – selected third and second, respectively, in the 2023 draft – are just getting started.

“I’m excited to be in it and to be on this team and in this city. I don’t take that for granted,” Stroud said. “But I think Will is right. We have a lot of ball left in our careers, God willing. We’re going to learn from this and move on.”

That sounds nice. It’s also contingent on the Texans not moving on from him first.

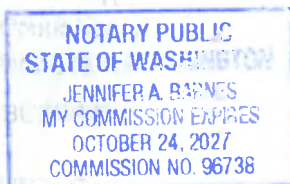

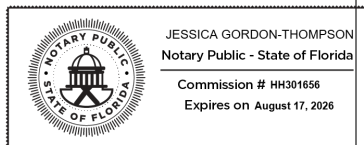

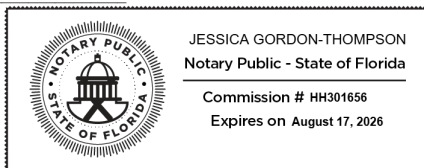
