

Customer T-Shirt Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.

By participating in the Sys Admin T-Shirt Giveaway ("Giveaway"), you affirm that you have read and agree to be bound by these terms and conditions ("T&Cs") and the decisions of Sponsor, which shall be final.

1. **Sponsor.** Vasion, Inc. (d/b/a Vasion) 432 S. Tech Ridge Drive, St. George, Utah 84770 USA.
2. **How to Enter.** To participate in the Giveaway, within the Giveaway Period (defined below), the individual who is invited by Sponsor to participate in the Giveaway ("**Participant**" or "**you**") must complete the submission [form](#), which includes but is not limited to Participant's name, email, and mailing address (collectively, a "**Submission**"). Each Participant may only enter the Giveaway one (1) time, and is only eligible to collect one T-shirt (defined below). No automated entry devices and/or programs permitted.
3. **Start/End Dates.** Giveaway begins at 10 am MST on July 7 and ends at 11:59pm MST on August 1, 2025 ("**Giveaway Period**"), or until the limited quantities described in Section 6 run out, whichever is earlier.
4. **Eligibility.** The Giveaway is open to all invitees of Sponsor who are at least 18 years of age and are legal residents of countries that are not export limited or restricted by the United States, UK, or Germany. For clarity, Submissions made in response to forwarded invites from Sponsor may be rejected by Sponsor in its sole discretion. Notwithstanding the foregoing, the following are not eligible to enter the Giveaway: (a) employees of Sponsor as well as the immediate family (spouse, parents, siblings and children) and household members (whether or not related) of each such employee; and (b) employees, officers, directors or agents of any government entity, including federal, state and local government officials, judges, elected officials, regulatory agency employees as well as their immediate family (spouse, parents, siblings and children). The Giveaway is subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations and is void where prohibited by law.
5. **T-Shirt.** Within approximately 24 weeks following completion of a Submission Sponsor shall provide a promotional t-shirt (to the address provided in the Submission, unless otherwise agreed by Sponsor) to the applicable Participant. (the "**T-Shirt**"). T-Shirts are non-transferable. No substitutions or cash redemptions. In the case of unavailability of the T-Shirt, Sponsor reserves the right to substitute an item of equal or greater value. Sponsor reserves the right to not award a T-Shirt (a) in the event there is not at least one complete Submission; or (b) in the event the Participant eligible to receive the *T-Shirt* fails to provide to contact information Sponsor deems reasonably necessary to receive the *T-Shirt*. All unspecified expenses are the responsibility of Participant. *T-Shirt* may not be sold or refunded for any monetary gain. All federal, state and local taxes are the sole responsibility of the Participants, if applicable.
6. **Limited quantities.** This Giveaway is limited to a total of ONE THOUSAND FIVE HUNDRED (1500) T-Shirts. T-Shirts will be distributed on a first-come, first-served basis until supplies are exhausted. Vasion reserves the right to end the giveaway at any time once all available T-Shirts have been claimed. No rain checks, substitutions, or alternatives will be offered once the supply of T-Shirts has been depleted.
7. **Release.** Participants agree to release and hold harmless Sponsor, its subsidiaries and affiliated companies, units and divisions; each of their respective officers, directors, agents, representatives and employees; and each of these companies' and individuals' respective successors, representatives and assigns (collectively, the "**Released Parties**") from and against any claim, liability, or cause of action,

including, but not limited to, damage to or loss of property, arising out of participation in the Giveaway or receipt or use or misuse of any T-Shirt.

8. **Additional Terms.** Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Giveaway should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Giveaway. Sponsor is not responsible for late, lost, incomplete, delayed, inaccurate, invalid, un-intelligible, or misdirected Submissions; or other errors of any kind whether human, mechanical, or electronic. In the event of a dispute as to any Submission, the Authorized Account Holder of the email address used to submit the Submission will be deemed to be the Participant. The “**Authorized Account Holder**” is the natural person who is assigned an account by the Internet access provider, online service provider, or other organization responsible for assigning such accounts or the account associated with the submitted email address.
9. **Privacy Policy.** The Participants acknowledge and understand that any personal information submitted as part of the Giveaway will be collected and processed by Sponsor for the purpose of managing the Giveaway and for marketing use in accordance with Sponsor's privacy policy.
